Domaćinstva mogu aplicirati za iznose granta od 800 KM do 4.000 KM (80% od ukupnog investiranja) za ekonomsku podršku i prihodovne aktivnosti.

Applying households can apply for a grant amount between 800 BAM and 4,000 BAM (80% of the overall investment) to support economic and income generating activities.

Grantovi mogu podržati samo jednu prihodovnu aktivnost za jedno domaćinstvo. Domaćinstva koja apliciraju za više grantova odnosno gdje članovi istog domaćinstva apliciraju istovremeno će biti isključeni iz daljeg procesa.

The grant applied for can support only one livelihood activity for one household. Individual households applying for more than one grant will be excluded and applications from two or more persons of the same household will be disregarded.

Da bi bili razmatrana za podršku, domaćinstva koja apliciraju moraju obezbijediti finansijsko učešće u iznosu od 15% do 20%. Učešće u robi ili usluzi neće biti prihvaćeno.

To be considered for support, applying households must provide a financial contribution between 15% and 20%. In-kind contributions will not be accepted.

Projektna ideja:

Preferisane za podršku će biti ideje za domaćinstva čije ekonomske aktivnosti imaju korist za lokalnu zajednicu (kao što je obezbjeđenje nedostajućih dobara ili servisa), i koje će trajati i nakon završetka projekta. Projekat ima za cilj da podrži socio-ekonomski ugrožena domaćinstva i **doprinese kreiranju održivog okruženja koje obezbeđuje zaradu osnovnih ili dodatnih prihoda.**

Projekat neće podržati ideje koje (lista nije konačna):

- nisu u saglasnosti sa zakonom (npr. neregistrovani **OBRADA, PAKOVANJE ili PROIZVODNJA DUHANA**);
- podržavaju rad na sivom/ crnom tržištu;
- za koje nije jasno kako i gdje će se vršiti sirovinska nabavka (neregistrovane **ČUMURANE**);
- su vezane za nabavke ili čuvanje stoke ili živine (izuzetak može biti napravljen samo ako postoji osnovno stado, farma je registrovana ili će biti registrovana, a nabavka dodatne stoke će dovesti do zapošljavanja dodatnih osoba);
- imaju za cilj nabavku i rad sa plastenicima, a prethodno su već podržane kroz projekat Caritasa Švicarske ili drugih organizacija aktivnih u ovom sektoru;
- su vezane za ugostiteljski sektor (npr. opremanje apartmana ili kuća za turiste);
- ne pokazuju finansijske rezultate u periodu od najviše 12 mjeseci od početka poslovnih aktivnosti.

Project idea:

Preferred for support will be ideas of household-based economic activities that benefit the local community (such as providing lacking goods or services) and that will potentially endure beyond the project. The project aims to support socio-economically vulnerable households and contribute to **creating sustainable livelihoods allowing to earn a basic or additional income.**

The project will not support ideas, which (none exhaustive):

- are not in accordance with the law (e.g. unregistered **PROCESSING, PACKAGING OR PRODUCTION OF TOBACO**);
- support activities in the grey/black market;
- are unclear where and how raw materials are acquired (e.g. unregistered **CHARCOAL** processing);
- are related to purchasing or keeping of livestock or poultry (exceptions can be made only if herd already exists, the farm is registered or will be registered and the additional livestock will lead to the employment of additional persons);
- aim procuring and operating of greenhouses, if already supported by other CaCH or other organisations' activities in this sector;
- are related to the hospitality sector (e.g. furnishing of apartments or houses for tourists) ;
- do not show financial results in period of max 12 months since beginning of the business activities

Examples of activities eligible for support by this project (none exhaustive):

- procurement of agricultural equipment, inputs and machinery for small mechanization;
- procurement fruit and vegetable processing equipment or machinery (e.g. for production or packaging) for households that are already engaged in or plan to engage and intend to produce and sell domestic products for the local, regional or national markets;

- procurement of greenhouses for flower production;
- procurement of one additional greenhouse if the family owns only one and wishes to register as an agricultural producer;
- proposals submitted by women in **economically difficult situations**
